PUBLIC POLICY NOTES

With a lot of activity on the last day of the Assembly, the lawmakers passed a bill to require lifetime supervision of sexual predators, update its online sex-offender registry, triple mandatory minimum sentences for rape and assaults of young children and make it harder for repeat offenders to get out of jail.

A first of its kind measure is to require schools and police to share information about students and classroom interventions with those that teachers believe to be heading toward gang involvement. Legislation to make it easier to prosecute gang members and stiffen penalties against them was approved. The current law, Gang Prosecution Act of 2007, resulted in only one guilty plea and no convictions in nearly three years. This bill would add crimes that would make gang members eligible for stronger penalties, including witness intimidation and second-degree assault.

Child support payment guidelines will be changed for the first time in twenty years. It will raise the scale of payments based on combined monthly income between parents from \$10,000 presently to \$15,000.

Maryland utilities will have to increase the amount of solar energy they buy and pay fees for not complying. It is estimated that residential electric bills will go up by 5 cents per month next year. The amount will go up each year, resulting in an increase of 77 cents per month for residents by 2016.

Sixteen-year-olds will be able to register to vote when they get their driver's license. They won't be able to vote until they reach eighteen.

It is with great sadness we inform you of the death of our National FCE President Bettie Lucas. The following is a copy of the obituary that appeared in The Parkersburg News and Sentinel.

Mrs. Bettie Lucas
Bettie Lucas, 61, of Washington
passed away Apr. 20, 2010 at
Marietta Memorial Hospital after a
courageous battle with cancer. She
was born Dec. 27, 1948 in
Manchester, TN to Lonnie M.
Foster Brandon and the late
Kenneth O. Brandon. She was an

active member of the Marrtown Road Church of Christ. She was a former local, state and national president of the National Association for Family and Community Education (FCE). Bettie worked with several groups in Parkersburg in conjunction with the FCE, such as, the Appalachian Comprehensive Cancer Coalition, founder and director of Wood County Youth as Resources, affiliate of WVFCE, the ACWW (Assoc. of Country Women of the World), secretary of the Board of Directors of the former YWCA, member of CHARACTER COUNTS! Coalition, GFWC Williamstown Womans Club, the Wood County Family Resource Network, Literacy volunteer, and ARC of Wood County volunteer. Bettie spent many, many hours writing and receiving grants to educate and pay for medical treatments for breast, ovarian and cervical cancers. Bettie also worked with the Athena Health Center to make available many grants to help numerous women receive screenings for all types of cancer and to help raise doctor awareness.

In addition to her mother Lonnie, Bettie is survived by her husband, Scott Lucas, whom she married on Oct. 9, 1982 in Peoria, Ill.: one brother, Ed Brandon; several nieces and nephews; and her beloved dog "Millie".

26th Triennial Conference of the Associated Country Women of the World Hot Springs, Arkansas – April 21-28, 2010 Theme: Women Worldwide – The Voice of Today

Officially named in 1933, the Associated Country Women of the World (ACWW) currently has 360 member societies active in over 70 countries and has consultative status at the United Nations. When ACWW meets every three years the meetings follow a very strict procedure to insure equality for all delegates. During the years between meetings various committees meet in the ACWW office in London to carry on the business of the organization. The triennial meetings are held in various countries and this year the USA was the host. The Convention Center was spacious so delegates and attendees could attend all meetings.

April 21 – Arrived at Hot Springs, AR. We

presented our credentials and collected our

conference voting papers. We set up our Maryland FCE exhibit showing our yarn and embroidery thread project for India. We rehearsed carrying 74 flagpoles for the opening ceremony. (Flags had not arrived due to the eruption of the volcano in Iceland.) April 22 – The nine geographic areas of ACWW held individual meetings in the morning. At the USA meeting, which is also our Country Women's Council (CWC), we learned that we will need a new newsletter editor and that there were over 100 applications for the Ruth Sayre scholarship this year. The Council Meeting followed with changes to be made in the agenda because delegates could not leave Europe due to volcanic ash. Minutes from the 2007 triennial were accepted and reports were given on work done from 2007-2010. Everyone wants the same respect and values around the world. The treasurer's report revealed that finances are very tight for ACWW. We need to stress sending Pennies for Friendship to London. The flags arrived in time for the Opening Ceremony in the evening and we had an excellent keynote address from the head of the Hot Springs National Park. (The city of Hot Springs is a national park and is the first national park in our country. Our latest monetary quarters are of the national parks and we each received a quarter of Hot Springs issued that day.)

April 23 - First Plenary (meeting) – World President Dato Ursula Goh spoke of her six years of travel for ACWW to remote villages and how they have widened her horizons. She is extremely impressed with the effect of our various ACWW self-help projects and the quality of concerns of women around the world. She also stressed the need for ACWW to find a stable means of income. Second Plenary – The nine Area Presidents elaborated on their written reports with detail and stories of events experienced carrying out resolutions and recommendations from the last triennial. (We have a copy of all of the reports.) Consideration of Resolutions and Recommendations began. Voting for a resolution means that the content of the resolution is to be followed during the next three years in some way. Voting for a recommendation means that it is suggested to follow the content of recommendation during the next three years.

April 24 – Third Plenary – A resolution to give access to credit for women was passed. We had a speaker who encouraged laughter to combat stress. We rotated through three workshops on Leadership, Laughter, and Recycling. The following resolutions were passed: To stop the use of plastic bags and reduce excess packaging; To ensure that women have access to knowledge about financial management; To retain sufficient arable land for food production versus growing crops for bio-fuel production. One evening during the triennial the host country provides a program of local culture. Photos of regions of the USA were projected on screens and the entire room had displays, mainly related to farming and agriculture – you could even milk a life size artificial cow! Did you know that Arkansas is a major producer of rice? Everyone consumed red, white and blue frosted cup cakes and opened their beautiful souvenir gifts of miniature farm scenes from the Iowa Farm Bureau. A country blue grass band played tunes for all who wished to sing and dance...and they did!

April 25 – Fourth Plenary – Introduction of nominees for election and voting. The voting procedure is extremely well organized and time consuming as there are candidates for ACWW as a whole and candidates for the various worldwide area positions. Following the elections reports were presented from the Projects Committee and Promotion and Publications Committee. The Projects Committee met six times during the triennial and approved 42 applications, 22 from member societies. 152 groups

and individuals have taken on projects. Safe water is still a priority everywhere. The Promotion and Publications Committee publishes the ACWW Country Woman magazine quarterly. They have just published a small brochure and bookmark that are wonderful tools for marketing ACWW and can be ordered from London. Fifth Plenary – Report on Agriculture encouraged teaching children to farm and the United Nations Committee report centered on violence against women and treatment of women in wars and conflict. The Penfriends and Links Committee tries to match pen pals with similar interests, ages, etc. (We have complete reports from these committees.) In the evening attendees could make various crafts using beads of all colors, sizes and shapes. Everyone made an ACWW key ring. April 26 – The morning began with an Interfaith Service followed by a day of tours. On the triennial day of tours buses are filled and given various itineraries for the rest of the day to visit local points of interest. The buses do not visit the same locations so everyone comes back with various tales about where they went, how their bus broke down or the air conditioning didn't work! Of great interest to our bus was being served lunch by Extension Homemakers in a lovely building that they own! We also visited a garden, a mall, a family owned pottery shop and the famous Hot Springs bath houses.

April 27 – Sixth Plenary – Results of the election were presented. An urgency resolution to increase membership dues by 5% for the 2011-2013 triennium was presented and carried. Recommendations to plant trees and to require candidates for office on the ACWW Board to hold individual memberships were carried. The new World President, May Kidd (Scotland) was introduced during the mid-morning Closing Ceremony. Also there was Presentation of Chain of Office and Presentation of Badges to Incoming Board Members followed by the recession of the flags. An afternoon Council Meeting summarized events of the conference. Later, area meetings revealed the Farm Bureau will withdraw from the USA Area CWC. This will be a major loss to the organization. In the evening there was a pregala social hour featuring the National Parks Community College Vocal Jazz and Instrumental Group and the Gala Dinner entertainment was by a Hot Springs Flute Ensemble. Dinner tables were hosted by representatives sharing information about their home states. Guests received crystal plates engraved with the conference logo, date and location.

ACWW Trivia -

- Each triennial is represented by a pin. CWC held a contest for the 2010 design. The winning design features the American flag.
- Many countries wear special native costumes or specially designed attire. We wear navy blue slacks or skirts, red blouses, white jackets and red, white and blue stars and stripes scarves EVERYDAY (except on the tour day and to the gala dinner).
- English is accepted as the universal language at the conference.
- Informal and friendly conversation is shared everyday with morning and afternoon tea breaks.
- There was a Country Store which was very attractively organized and featured quality goods. Maryland FCE can be complimented for their contributions.
- Each day there was a lottery for three items to raise money for Pennies for Friendship.

- There was drawing for a quilt.
- 130 9x9" quilt squares were entered in a contest for judging and then auctioned off. Martha Moser, Frederick County FCE, made three squares which netted a total of \$30.
- Many organizations brought interesting exhibits of their projects.
