82nd Annual National Association for Family and Community Education Conference

Austin, Texas ~ Thursday, July 19 - Sunday, July 22, 2018 Theme: Reach for the Stars

Maryland Attendees: Barbara Perry, Jeanne and Ed Purich, Marilyn Simonds and Sue Van Slyke

Sixty individuals attended the conference with thirteen states represented (nine presidents and four delegates). In three years we've lost 2/3 of our members. Currently we have 3,299 members in 17 states.

The organization is in dire financial straits. The organization is \$11,000 in the red. To aid in addressing this:

1. The newsletter, FCE Today, will be sent by email to all members. Presidents are responsible to send copies to those who do not have email. This saves money and provides better communication. 2. Judy Jones, national office secretary, is now working a three day week (saving \$5,000).

3. Changing our website provider is now \$160 (was \$1,200) and Judy Jones and Scott Teeples now have access as webmasters at any time with no extra fee.

4. Board members meet by phone, email, etc. and pay most of their own expenses for one meeting annually.

5. At the end of each president's term she/he may recommend raising the dues. This could happen now. It is estimated that we need to raise dues \$10.00. It was voted to postpone a vote on a dues increase until the 2019 annual conference.

6. The Board did not receive many reports or brochures from the states this year. It was suggested to have no reports next year. Instead, a summary of each association's activities including statistics is needed.

7. A cheaper insurance premium is needed. An investigation on other plans will be made.

8. A Legacy Fund was begun several years ago with the anticipation of warding off financial problems. States and individual members were asked to pledge \$5,000. (Maryland paid the whole amount to help get the fund started.) Unfortunately, immediate action was not taken and the money given is not bringing the needed dividend. (\$34,915 is in an Edward Jones Mutual Fund.) The money needs to be reinvested and we need more pledges.

Two amendments to the bylaws were passed clarifying officer terms of office and "Legacy Fund" was added denoting a committee of three who are knowledgeable about finances and investment funds.

Public Policy: 20 people received 30 hour FCL certificates (mainly from Tennessee), One received 60 hours. Barbara Perry was awarded the Spirit of FCL award and the Heart of FCE award. (Booklet)

We saw videos of the winners of the Character Counts Art and Essay Contest (1st. Oregon, 2nd. Hawaii, 3rd. Missouri).

The keynote speaker was ACWW World President, Ruth Shanks who shared ACWW news and gave a detailed presentation about three recent projects and the system of funding them from "categories" rather than actual individual projects. Ruth and Joe Ellen Almond, ACWW USA Area President spoke on the following subjects:

<u>Friendship Link Letters</u>: can be exchanged by snail mail, email, Skype, etc.

Zero Hunger Challenge: Dimes are being collected to challenge hunger in the USA and the World.

<u>ACWW Triennial</u>: To be held in Melbourne, Australia April 4-10, 2019.

<u>ACWW Statistics</u>: Begun in 1929. There are 400 societies in 80 countries in nine areas of the world.

<u>Rural Women Survey</u>: Everyone is encouraged to take the on line survey by December 31, 2018. Go to www.ifrw.org.uk for survey. <u>Pennies for Friendship</u>: Started collecting in 1930's. It is the ACWW enabling fund today. FCL Workshops:

• Grow as a Volunteer - Issue Analysis and Resolution

• Stop This Epidemic Now: Opioids - Public Policy

• Wills, Trusts and Funeral Plans - Group Process

• Individuals, Groups or Teams - Volunteer Hearth Fire Presentations and Programs:

• Asking for a Friend...How Does Aging Affect My Senses?

• Someone's in Your Home...Eating Healthy Food The conference included an excellently

narrated tour of downtown Austin (including the capital building and parts of the huge campus of Texas University). The tour then headed to the hills of central Texas where we had a "Salt Lick" famous brisket BBQ luncheon.

The Sunday morning inspirational service, which included music by the "Sweet Memories", was followed by a craft session for attendees to create a wreath using bandanas or fabric.

The 2019 conference will be in St. Louis. Start planning to attend!

Dubuque Iowa September 9 – 14, 2018

The Dubuque American Legion Post 6 Color Guard opened the meeting at 9 AM with the presentation of colors and the National Anthem. The Flag prayer was also preformed explaining that white is for purity, red for courage and blue for tranquility, happiness and peace. Opening ceremonies continued with the Pledge of Allegiance, the singing of America the Beautiful and introductions of the CWC board members. Mayor Ray Buell and the Iowa Master Farm Homemakers Guild (IMFHG) president, Marylou Ahrens brought greetings and invitation to the 90th Anniversary of IMFHG.

Motions included:

• Beverly Earnhart, newsletter editor, stated that it costs \$346.66 to mail 302 newsletters. The current cost does not cover the mailing. Life members (103 members) do not pay for the newsletter. Motion was made to increase fee to \$21.00. Motion was carried.

• A second motion was made to increase the cost of newsletter to \$27.00 which will better cover the cost of mailing the newsletter. Motion was approved with 2 opposed.

• A motion was made to increase the society membership dues by \$15.00.

Currently Category societies I pay \$75.00 would increase to \$90.00; II pay \$50.00 would increase to \$65.00; III pay \$25.00 would increase to \$40.00.

Vote was 4 yes, 10 no, 2 abstentions – Motion failed.

• A motion was made to increase all categories by \$25.00.

Vote was 5 yes, 10 no, 1 abstention – Motion failed. The ACWW project 1023 – India -

enhancement of nutrition and health security through home gardens for Dalet women still needs funding of \$1182.47. \$3081.71 was collected in 2017 and \$210.82 was collected in 2018.

Ruth B Sayers scholarship had 37 applications with 2 applications being disqualified.

Five were from Alabama, 15 from Iowa, 12 from Indiana and 3 from Wisconsin. There were four scholarships awarded, one each in the four states that sent applications.

The webmaster, Pam Hanfland, updated the web site with the CWC newsletter, registration, board members and society members. All info for Facebook should be sent to Pam (phanflan@gmail.com) and she will post.

The rotation of officers incoming for 2019 are the Affiliates – Vice President. Debbie Mott will fill the position. A secretary is also needed. Later in the meeting, a secretary was chosen, Becky Conley. A new treasure is needed.

Friendship Links – Pen Friends – societies can also be a pen friend. There is a 105 year old that still gets letters from her pen friend.

The proposed budgets for 2019 and 2020 were unanimously approved.

ACWW Report.

There are 412 societies, 9 million women and 72 countries belong to ACWW. Everyone is encourage to take the Rural Women survey that is on the ACWW website (www.ifrw.org.uk).

There are two resolutions that are being put forth by CWC.

• Be it resolved to continue financing and supporting the research needed to eliminate the world wide incidence of iron deficiency.

• Be it resolved to continue to identify and reduce specific drivers of insect pollinator decline, developed agricultural pollinator friendly practices and promote greater public awareness of the role of insect pollination in the global food production.

Other resolutions include the following areas. Exact wording of the resolution will come out later.

- Protection of coral reefs
- Map and register old landfill sites
- Eliminating plastics
- Climate change, decrease greenhouse gas
- Women work for fair wages
- Domestic violence
- Gender sensitive care
- Nutrition for women
- Rabies
- Query fever
- Toileting with dignity, sanitation

Jo Almond reported:

Zero Hunger has collected \$2,699.42 so far. The campaign will continue until April 2019.

She reviewed the summit meeting in Indianapolis. Talks included human trafficking and what other organization can we partner with.

ACWW Projects in Common – instead of funding individual projects as we have done in the past, ACWW wants everyone to fund the "WE Fund" which will be a general projects fund. ACWW will decide how the money will be distributed.

Pumpkin Crisp

Prep 30 m Cook 1 h Ready in 1 h 30 m

Ingredients

- 1 (18.25 ounce) package yellow cake mix
- 1 egg
- $\frac{1}{2}$ cup butter, melted
- 1 (29 ounce) can pumpkin puree
- 2 eggs
- 1 teaspoon ground nutmeg
- 1 teaspoon ground cinnamon
- $\frac{1}{2}$ cup white sugar
- ²/₃ cup evaporated milk
- ³/₄ cup white sugar
- $\frac{1}{2}$ cup butter, softened



Directions

1. Preheat oven to 350° F (175° C). Set aside 1 cup cake mix for the topping. Combine remaining cake mix, 1 egg, and melted butter or margarine. Pat into a 9 x 13 inch baking pan.

2. In a large bowl, mix pumpkin, 2 eggs, spices, 1/2 cup sugar, and milk. Pour pumpkin mixture over the cake mix crust.

3. In a small bowl, combine 1 cup cake mix and ³/₄ cup sugar. Cut in ¹/₂ cup softened butter until mixture resembles coarse crumbs. Sprinkle mixture on top of pumpkin mixture.
